## NEEDS OF SCHOOLS MUST COME FIRST, STATES FARLINGER

Finance Committee Is to Grant Funds for Improvements, Even If It Means Sacrifices in Other Departments.

### LAST PUBLIC HEARING WILL BE HELD TODAY

Departments, Which Have Not Yet Been Heard From, Must Make Showing at Today's Sessions.

Impressed by the arguments of the finance committee of the board of education for an appropriation of \$1,734,000 for school improvements which they consider imperative the general council finance committee Wednesday began a careful analysis of the budget with a view to granting many of the requests even if it means a sacrifice in other departments.

No city department yet before the committee has put up such a good argument for an increased appropriation and we must provide for them even though we have to hold up some of our other improvements for one year announced Chairman A. W. Farlinger of the finance committee. Other improvements can wait a while but the welfare of our children must be cared for.

The finance committee will end its public hearings today and all departments that have not been heard from are requested to have their representatives appear today and state their needs. Following today's sessions, the committee begins the preparation of its budget to be submitted to general council.

**Present School Needs**

President R. J. Guinn and Chairman Dan W. Green, of the finance committee of the board of education, presented the needs of the schools to the committee.

With an anticipated net increase of 1,100 pupils in the high school next fall and with the four high schools already filled to their capacity, the board of education stressed the importance of making their improvement one of the first considerations.

It was stated that twenty-nine new teachers would be required in the high school department and since the upper eight grades will be moved to the high schools no new teachers will be needed in grammar schools. The increase in the grammar schools can be cared for with teachers and equipment formerly used for the eighth grades.

Chairman Green outlined in detail the needs of the four high schools and declared that the proposed appropriations are made hundreds of boys and girls would be forced to stay out of school next fall. The following appropriations were asked:

**Appropriations Asked**

For Guinn High school to provide for new equipment, rent of a house adjacent to the main building and the employment of ten additional teachers \$4,747.

For four room annex to English Commercial High school and assembly hall with equipment and five additional teachers \$4,830.

For new concrete annex with furnishings, machinery and eight additional teachers for Tech High school \$10,000.

This represents a total of \$38,440 for the four high schools which the board of education considers as of primary importance.

They also asked for 3,000 additional for each of the four new school buildings provided for in the January money bill, making a total of \$20,000 to complete and equip for use next fall. The

#### EXPRESS COMPANIES COMPLAIN OF RATES

Washington, May 26.—Representatives of the four prominent express companies appeared before the Interstate Commerce Commission today to justify their petition for a modification of its orders which would increase their gross revenues about 3½ per cent. The companies are asking permission to alter the fundamental rates plan, but that changes should be made in terminal allowances and a reduction per ton of the weight down to 100 pounds from 2½ cents to 1 cent. In their petition the four companies set forth that ten months' operation under present conditions made a deficit of \$300,000.

The petitioning companies represent 95 per cent of the express business in the United States.

#### MRS. STUYVESANT FISH SUMMONED BY DEATH

Garrison, N. Y., May 26.—Mrs. Stuyvesant Fish, leader of New York's social set, is dead at Glen Cliff, her summer home. She died last night of cerebral hemorrhage after an illness of only a few hours.

Shortly after luncheon yesterday she became ill and Dr. Richard Gileas was summoned from Cold Spring. At the time she was stricken, she was planning a garden party and luncheon to be given within a few days on her estate. She failed to rally, and died soon after 10 o'clock. Her husband was with her but bore three children, Stuyvesant, Sydney and Mrs. Albert Gray, did not reach the house till a short time after she died.

Mrs. Fish was about 50 years old. She was born in New York. Her maiden name was Marion Graves. When, on June 1, 1876, she was married to Stuyvesant Fish, a well-known railroad magnate and son of Abram Fish, secretary of state under President Grant, with her husband she entertained liberally. Funeral services will be held Friday.

## FURIOUS ATTACKS MADE BY TEUTONS IN EAST AND WEST

#### Entrance of Italy Into War Hasn't Caused Austro-Germans to Relax Efforts on Other Fronts.

London, May 26.—Although called to face another enemy in Italy, whose troops have crossed the eastern border, the Austrians and Germans have not relaxed their efforts on the other fronts.

In middle Galicia they have resumed the offensive against the Russians along the River San and claim further success while in Planders and Artois the Germans continue, according to the French report, their furious attacks in an effort to regain ground taken from them in recent weeks and to hold that which they took from the British.

Except for the German admission that the British have captured part of their trenches northeast of Olivenchy, the reports of the belligerent headquarters continue to contradict each other.

An engagement of extreme violence is in progress north of Arras, where the Germans are trying to retake captured positions, and a similar condition prevails at the northern outskirts of the wood north of the road from Aix-Nordelle to Souchez, where the French report a slight advance.

The British are reported by Paris to have made a strong advance near La Bassée. The British war office says in a recent speech that the British have picked the German line for a total front of over three miles.

#### MORE PROGRESS FOR BRITISH.

London, May 26.—The following of final statement was issued by the British war office tonight:

"The first army continues to make progress east of Festubert. A territorial division earned last night a group of German trenches capturing 20 prisoners and this morning it captured one officer, 21 men and a machine gun."

The total number of prisoners taken is eight officers and 172 men and the British war office adds that the British have taken 100 prisoners.

## REBATE CLAUSE STICKS IN TARIFF

Court Holds Goods Imported in American Ships Are Entitled to 5 Per Cent Reduction—Decision Costly to Government.

Washington, May 26.—The so-called "per cent clause" of the tariff law granting a reduction of duties to that amount on goods imported in American ships was sustained today by the customs court, which held also that the per cent rebate must be granted on all goods imported in ships of those countries with which the United States has favored nations status.

As such treaties exist with the principal countries of the world the ultimate effect of the decision is to reduce the customs revenue a per cent.

New Tariff \$15,000,000.

If the decision is sustained by the supreme court of the United States approximately \$15,000,000 in duties already collected must be refunded.

In dissenting opinion Judge De Vries pointed out that the majority decision means that goods imported from about 5,500 foreign vessels of favored nation countries shall receive a reduction in customs duties. Five per cent of the estimated customs revenues for the present fiscal year would exceed \$11,000,000 and in years to come this total would grow to even greater proportions. Moreover, it was pointed out that the decision if it stands the test in the supreme court is retroactive to the extent that it applies to importations into the United States since approval of the Underwood-Simmons law more than two years ago.
